Chapter 105 Operational Permit Analysis

Chapter 105 of the IFC established the operations, processes, and uses that require permits from the Fire District.

In nearly all cases, the building's certificate of occupancy (C of O) will serve as the "permit" to operate within the building required by IFC 105.1.1 and C of O's are in effect until the building is modified, the Use Group is changed, or the occupancy load increases.

When a use changes, the fire code official will determine whether to require a separate permit, or to continue to use the C of O using the following process:

- 1. If the Use Group changes without concurrent construction the CBO will be consulted to determine if a new life safety analysis is required. Generally, a reduction in hazard or occupant load should not require a new analysis, where increases in hazard or occupant load will. See IFC 2018 Chapter 11.
- 2. If the change of Use involves permitted construction, the new life safety analysis will be completed during the plan review portion of the permit process.

If a C of O cannot be produced, the fire code official will use the following process to determine whether to issue a separate operating permit, or require the building owner/responsible party to obtain a new C of O from the City of Evans.

- 1. If the business is open and operating, and can verify they have been in uninterrupted operation *in the same type of business* (change of ownership, notwithstanding) for at least five years, and there have been no modifications, or construction that would have required a building permit, the fire code official may issue an operational permit to meet the requirements of IFC 105.1.1. The operational permit shall include:
 - a. The Use Group
 - b. The calculated occupant load.
 - c. Any special conditions the fire code official determines are necessary to comply with the fire code.
- 2. If the business cannot demonstrate they have been open and operating for five years, if there have been unpermitted modifications, if the Use Group, hazard or occupant load has changed, or if in the opinion of the fire code official there are other circumstances that require review by the building official, the lack of a C of O will be noted as a fire code violation and the owner given 180 days to obtain a C of O from the City of Evans.

Discretionary permits will be required where, in the opinion of the FCO other, relevant sections of the fire or other codes, or the Certificate of Occupancy is/ are not enough to ensure a reasonable level of life safety and property protection, or to periodically monitor situations that present unique hazards.

The listed fee's are effective 1/1/2021.

The highlighted uses below, require in all cases, a specific, separate permit in addition to the C of O.
