RESOLUTION BOARD OF DIRECTORS EVANS FIRE PROTECTION DISTRICT

A RESOLUTION ADOPTING A FEE SCHEDULE FOR INSPECTIONS FOR FIRE CODE COMPLIANCE, EFFECTIVE JUNE 23, 2015

WHEREAS, the Evans Fire Protection District ("Fire District") is a political subdivision of the State, organized pursuant to the Special District Act, C.R.S. § 32-1-101, et seq., to provide fire suppression, fire prevention and public education, emergency medical, emergency rescue, and hazardous materials services to the citizens and property within its jurisdiction, and to individuals passing through its jurisdiction;

WHEREAS, pursuant to State statute, the Fire District Board of Directors ("Board") is authorized to fix, and from time to time increase or decrease, fees and charges for requested or mandated inspections to determine compliance with any applicable Fire Code adopted by the Board and the governing body of any applicable municipality or unincorporated portion of any County; and requested inspections to determine compliance with any applicable Fire Code adopted by the Board, whether or not the Fire Code has been adopted by the governing body of a municipality or County (collectively, "Inspection Services"). C.R.S. § 32-1-1002(1)(e); and

WHEREAS, the Fire District's Chief Staff has developed a proposed schedule of fees and charges that reflect the costs the Fire District incurs in providing the Inspection Services ("Inspection Fee Schedule"). A copy of the proposed Inspection Fee Schedule is attached to this Resolution. The Board has reviewed the proposed Inspection Fee Schedule and finds that the fees and charges set forth therein are reasonable and necessary to cover the costs that the Fire District incurs in providing the Inspection Services.

NOW THEREFORE, be it resolved by the Board of Directors of the Evans Fire Protection District:

- 1. Effective June 23, 2015, the attached Inspection Fee Schedule is adopted as the schedule of fees and charges that the Fire District shall charge for the Inspection Services, and shall supersede and render null and void all prior schedules of fees and charges adopted by the Board for such Inspection Services, if any.
- 2. The Fire District shall issue invoices for fees and charges assessed in accordance with the Inspection Fee Schedule pursuant to the Fire District's invoicing procedures, as they may be amended from time to time. All fees and charges collected shall be remitted to the Fire District's General Fund.
