

DISCUSSION: 2026 PRELIMINARY BUDGET

Ms. Bowles reviewed the current sources of revenue the District receives. She then reviewed several budget scenarios for future years, to illustrate to the Board the District's financial position. Ms. Bowles

noted that without a change to revenue sources, the District will incur a revenue shortfall in 2027 and will begin losing staff and deferring regular equipment maintenance and replacement. Ms. Bowles then presented several budget scenarios to illustrate the impact of a potential sales tax for the District; various tax amounts were discussed.

REVIEW & CONSIDER RESOLUTION 2025-05 ENACTING SALES TAX, RESOLUTION 2025-06 CALLING FOR REGULAR MAIL BALLOT ELECTION, AND IGA WITH WELD COUNTY TO PARTICIPATE IN COORDINATED ELECTION

Attorney Powell noted that both resolutions and the IGA with Weld County could be discussed and adopted as a package as they all would need to be approved for the Board to present a ballot issue in November. The Board discussed the budget scenarios presented, future needs of the District, potential sales tax revenues, and the purchases that would be exempt from that sales tax. Director Schanwolf moved to approve Resolution 2025-05 with a 1% sales tax collecting \$3,618,195 in the first year, Resolution 2025-06 and the IGA with Weld County, as presented. Director Naylor seconded. Motion passed unanimously.

REVIEW & CONSIDER CONTRACT WITH CIRCUIT RIDER OF COLORADO

Attorney Powell discussed some of the tasks and legalities involved in placing a TABOR issue on the ballot and the benefit of hiring a consultant to assist with these tasks. Director Naylor moved to approve the contract with Circuit Rider of Colorado. Director James seconded. Motion passed unanimously.

The Board of Directors ("*Board*") of the Evans Fire Protection District ("*District*"), Weld County, Colorado, held a regular meeting and public hearing at Evans Fire Station 2, 2100 37th Street, Evans, Colorado 80620, on Monday, September 22, 2025 at the hour of 6:30 p.m. concerning a proposed 2025 Supplemental Budget.

President Achziger reported that, prior to the meeting and public hearing, each Director was notified of the date, time, and place of the meeting and the purpose for which it was called. She further reported that a Notice of the public hearing on the proposed 2025 Supplemental Budget was published in the Greeley Tribune on Wednesday, September 17, 2025. Notice of the public hearing also was duly posted. Thereupon, Director ______ introduced and moved for the adoption of the following Resolution:

RESOLUTION 2025-08

A RESOLUTION ADOPTING A SUPPLEMENTAL BUDGET REGARDING THE APPROPRIATION OF MONEYS TO AND THE EXPENDITURE OF MONEYS FROM THE GENERAL FUND AND THE EXPENDITURE OF MONEYS FROM THE ASSET MANAGEMENT FUND; FOR THE EVANS FIRE PROTECTION DISTRICT, WELD COUNTY, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2025 AND ENDING ON THE LAST DAY OF DECEMBER 2025.

WHEREAS, the Board, after complying with notice and other statutory requirements, duly adopted a budget for fiscal year 2025;

WHEREAS, after adopting the 2025 budget and making appropriations thereunder;

- The Board determined the need to seek voter authorization to enact a sales tax and thereby retain an election consultant to assist the District's DEO in conducting the election.
- The Board approved a contract for the redesign of the District website to enhance transparency and communication with citizens.
- The Board approved the usage of Staffing Overtime and the reinstatement of the Part-Time Firefighter program to maintain staffing levels.
- Knox box upgrades were necessary due to changes in technology.

WHEREAS, the District Board authorized administrative staff to prepare and submit a proposed 2025 Supplemental Budget reflecting the additional appropriation to and expenditures from the General Fund, and additional expenditures from the Asset Management Fund, as set forth above;

WHEREAS, a proposed 2025 Supplemental Budget has been submitted to the District Board for its consideration. A copy of the 2025 Supplemental Budget is attached to this Record of Proceedings;

WHEREAS, due and proper notice, published and posted in accordance with the law, advised the public that (1) the proposed 2025 Supplemental Budget was available for inspection by the public at a designated public office; (2) a public hearing would be held on Monday, September 22, 2025; and (3) interested electors could comment on or file or register objections to the proposed 2025 Supplemental Budget any time before the public hearing; and

WHEREAS, a public hearing was held on Monday, September 22, 2025, and interested electors were given the opportunity to comment on, or file or register any objections to, the attached proposed 2025 Supplemental Budget.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE EVANS FIRE PROTECTION DISTRICT, WELD COUNTY, COLORADO:

- Section 1. **Election Services.** Appropriation to and Expenditure of Moneys from the General Fund. The Board hereby authorizes and approves appropriation to and expenditures of money from the 2025 Election Services budget, in the amount of \$60,250 to engage in a contract with a Special District Election Consultant and the Weld County Coordinated Election Agreement.
- Section 2. **Professional Services.** Appropriation to and Expenditure of Moneys from the General Fund. The Board hereby authorizes and approves appropriation to and expenditures of money from the 2025 Professional Services budget, in the amount of \$11,250 to engage in a contract with a website design firm.
- Section 3. **Personnel.** Appropriation to and Expenditure of Moneys from the General Fund. The Board hereby authorizes and approves appropriation to and expenditures of money from the 2025 Personnel budget, in the amount of \$35,000 to maintain appropriate staffing levels.
- Section 4. **Asset Management.** Expenditure of Moneys from the Asset Management Fund. The Board hereby authorizes and approves the expenditure of money from the Asset Management Fund for the necessary upgrades to Knox boxes carried on apparatus.
- Section 5. Purposes of 2025 Supplemental Budget Could Not Have Been Reasonably Foreseen. At the time the Board adopted the 2025 Budget in the fall of 2024, it could not have reasonably foreseen the expenses set forth in Section 1 through 4 above.
- Section 6. **Adoption of Supplemental Budget for 2025.** The Board hereby adopts the 2025 Supplemental Budget in the form attached to this Record of Proceedings.

CERTIFIED ORDER INCLUSION OF REAL PROPERTY INTO THE EVANS FIRE PROTECTION DISTRICT

THIS MATTER comes before the Board of Directors ("**Board**") of the Evans Fire Protection District ("**District**") upon the Petition of Mountain Cement Company, LLC ("**Landowner**"), which is the one hundred percent (100%) fee owner of certain real property more specifically identified in the Petition attached as **Exhibit A** ("**Property**"), for inclusion of the Property into the District's jurisdiction. The Board makes the following Findings and Order:

I. FINDINGS

- 1. The District is a political subdivision of the State of Colorado, formed pursuant to the Special District Act, C.R.S. § 32-1-101, *et seq.*, to provide fire protection, fire suppression, emergency medical, rescue, and hazardous materials services (collectively, "*Emergency Services*") to the citizens and property within its jurisdiction.
- 2. The Property currently is located within the jurisdiction and boundaries of the LaSalle Fire Protection District ("*LaSalle FPD*").
- 3. The Property has been annexed into the boundaries and jurisdiction of the City of Evans ("*City*").
- 4. In calendar year 2011, the City entered into an Intergovernmental Agreement for the Transfer of Emergency Services ("*IGA*") with the District. Pursuant to the IGA, it is the City's and District's intent that the District's boundaries and jurisdiction shall at all times include all property located within the City's corporate boundaries, as such boundaries may be adjusted from time-to-time through annexation or otherwise.
 - 5. The Landowner is the 100% fee owner of the Property.
- 6. The Landowner submitted a Petition to the District for inclusion of the Property into the District's jurisdiction.
- 7. Pursuant to C.R.S. § 32-1-401(1)(b), the District duly published notice of a public meeting to be held on September 22, 2025 to consider the Petition for inclusion of the Property.
- 8. On September 22, 2025, the Board held a public meeting to consider the Landowner's request that the Property be included within the District's jurisdiction. During the public meeting, the Board received no objection to the Landowner's request to include the Property within the District's jurisdiction.
- 9. The Board finds it is in the best interests of the citizens within its jurisdiction, the Property, and the Landowner, and is consistent with the District's obligations under the IGA, to include the Property within the District's jurisdiction immediately upon exclusion from LaSalle FPD's jurisdiction.
- 10. Having received no objection to the proposed inclusion during the public meeting, and after considering the proposed inclusion during its meeting on September 22, 2025, the Board

adopted a Resolution approving the Landowner's Petition for Inclusion of Property. A copy of the Resolution is attached as **Exhibit B**.

11. The District has complied with all statutory notice and hearing requirements set forth in C.R.S. § 32-1-401.

II. ORDER OF INCLUSION

Pursuant to C.R.S. § 32-1-401, *et seq.*, the Board hereby Orders inclusion of the Property specifically identified in <u>Exhibit A</u> immediately upon exclusion of the Property from LaSalle Fire Protection District's jurisdiction.

Pursuant to C.R.S. § 32-1-402(1)(b), after the date of inclusion into the District, the Property shall be subject to all of the taxes and charges imposed by the District and shall be liable for its proportionate share of the District's existing bonded indebtedness; however, the Property shall not be liable for any taxes or charges levied or assessed prior to its inclusion into the District, nor shall its entry into the District be made subject to or contingent upon the payment or assumption of any tax, rate, fee, toll, or charge that is not uniformly made, assessed, or levied for the entire District without the prior consent of the Landowner or approval of the electors of the Property.

- **THIS MATTER** comes before the Board of Directors ("**Board**") of the Evans Fire Protection District ("**District**") upon the Petition of Mountain Cement Company, LLC ("**Landowner**"), which is the one hundred percent (100%) fee owner of certain real property more specifically identified in the Petition attached as **Exhibit A** ("**Property**"), to include the Property into the District's jurisdiction pursuant to C.R.S. § 32-1-401 of the Special District Act.
- WHEREAS, the District is a political subdivision of the State of Colorado, formed pursuant to C.R.S. § 32-1-101, *et seq.* of the Special District Act, to provide fire suppression, fire prevention, rescue, hazardous materials, and emergency medical services (collectively, "*Emergency Services*") to the citizens and property within its jurisdiction;
- **WHEREAS**, the Property currently is located within the jurisdiction and boundaries of the LaSalle Fire Protection District ("*LaSalle FPD*");
- **WHEREAS**, the Property has been annexed into the jurisdiction and boundaries of the City of Evans ("*City*");
- **WHEREAS**, in calendar year 2011, the City entered into an Intergovernmental Agreement for the Transfer of Emergency Services ("*IGA*") with the District. Pursuant to the IGA, it is the City's and District's intent that the District's boundaries and jurisdiction shall at all times include all property located within the City's corporate boundaries, as such boundaries may be adjusted from time-to-time through annexation or otherwise;
- **WHEREAS**, pursuant to C.R.S. § 32-1-401(1)(b), the District duly published notice of a public meeting to be held on September 22, 2025 to consider the Landowner's Petition for Inclusion. The Notice of Public Meeting is attached as **Exhibit B**;
- **WHEREAS**, on September 22, 2025, the District Board held a public meeting to consider the Landowner's request that the Property be included within the District's jurisdiction;
- **WHEREAS**, during the September 22, 2025 public meeting, the District Board received no objection to the Landowner's request that the Property be included within the District's jurisdiction; and
- WHEREAS, the Board of Directors has determined it is in the best interests of the District, the District's constituents, the Property, and the Landowner, and is consistent with the District's obligations under the IGA, that the Property be included within the District's jurisdiction immediately upon exclusion from LaSalle FPD's jurisdiction.
- **NOW THEREFORE**, pursuant to C.R.S. § 32-1-401, the District Board hereby approves the inclusion of the Property identified in <u>Exhibit A</u> within the boundaries and jurisdiction of the

Evans Fire Protection District immediately upon exclusion of the Property from LaSalle Fire Protection District's jurisdiction.

Pursuant to C.R.S. § 32-1-402(1)(b), after the date of inclusion into the District, the Property shall be subject to all of the taxes and charges imposed by the District and shall be liable for its proportionate share of the District's existing bonded indebtedness; however, the Property shall not be liable for any taxes or charges levied or assessed prior to its inclusion into the District, nor shall its entry into the District be made subject to or contingent upon the payment or assumption of any tax, rate, fee, toll, or charge that is not uniformly made, assessed, or levied for the entire District without the prior consent of the Landowner or approval of the electors of the Property.

PETITION TO THE EVANS FIRE PROTECTION DISTRICT FOR INCLUSION OF PROPERTY

WHEREAS, the undersigned Petitioner is the 100% fee owner of certain real property, the legal description of which is attached hereto as <u>Exhibit A</u> ("Property");

WHEREAS, the Property has been annexed to the City of Evans ("City"). The Property also currently is within, and receives fire and emergency services from, the LaSalle Fire Protection District ("LaSalle FPD");

WHEREAS, in 2011 the City organized the Evans Fire Protection District ("Evans FPD") to provide fire and emergency services to all property then annexed to, or that in the future may be annexed to, the City;

WHEREAS, as a condition of the Annexation Agreement entered into by and between the Petitioner and the City, the Petitioner is required to exclude the Property from LaSalle FPD's jurisdiction and include the Property into Evans FPD's jurisdiction; and

WHEREAS, Petitioner has petitioned the Board of Directors of LaSalle FPD to exclude the Property from LaSalle FPD's jurisdiction, and desires to include the Property into Evans FPD's jurisdiction immediately upon its exclusion from LaSalle FPD, stating:

- 1. The Petitioner assents to and requests the inclusion of the Property into Evans FPD's jurisdiction;
- 2. The Petitioner understands and agrees that, pursuant to C.R.S. § 32-1-401(1)(c)(I), the Evans FPD Board may grant or deny this Petition in whole or in part, and with any conditions it deems necessary and appropriate;
- 3. The Petitioner understands and agrees that, pursuant to C.R.S. § 32-1-402, upon inclusion into Evans FPD, the Property shall be subject to all of the taxes and charges imposed by Evans FPD and shall be liable for its proportionate share of existing bonded indebtedness of Evans FPD; but the Property shall not be liable for any taxes or charges levied or assessed prior to its inclusion into Evans FPD; nor shall inclusion of the Property be made subject to or contingent upon the payment or assumption of any tax, rate, fee, toll, or charge, other than the taxes, rates, fees, tolls and charges which are uniformly made, assessed or levied for all of Evans FPD, without the prior consent of the Petitioner. The Property shall also be liable for its proportionate share of annual operation and maintenance charges and the cost of facilities of Evans FPD and taxes, rates, fees, tolls or charges shall be certified and levied or assessed therefore;
- 4. The Petitioner understands and agrees that, pursuant to C.R.S. § 32-1-402(1)(c), the Petitioner may be required to pay a one-time processing fee incident to inclusion of the Property within Evans FPD. If a fee is required, Petitioner agrees to pay the fee contemporaneously with the filing of this Petition; and
- 5. The Petitioner understands and agrees it cannot withdraw this Petition without the consent of the Evans FPD Board of Directors after Evans FPD has published notice of a public hearing on the Petition.

NOW THEREFORE, pursuant to C.R.S. § 32-1-401(1), the Petitioner respectfully petitions the Board of Directors of the Evans FPD to include the Property into Evans FPD's jurisdiction immediately upon its exclusion from LaSalle FPD's jurisdiction.

AGENDA ITEM DESCRIPTION:

1. Personnel Costs:

- a. Volunteer Firefighter Pension Fund Contribution: For the past ten years, the District has made an annual contribution of \$88,000 to the Volunteer Firefighter Pension Fund. This amount has been well above the actuarially required contribution. In addition to the District contribution, the State of Colorado has contributed \$22,123 to this pension fund for a total annual contribution of \$110,123. At the current benefit level, the actuarially required contribution is \$82,939. The Board may wish to consider lowering the District's share of the annual contribution so that the District and State contributions together equal the required contribution.
- b. <u>Firefighter Wage Adjustments</u>: A cost-of-living adjustment of 3% to the Skill Based Pay tables for Captains and Firefighters is recommended. Due to the flattening revenues, along with increased non-discretionary costs, an increase higher than 3% is not possible within the constraints of the 2026 budget.

2. Dispatch service

a. <u>UC Health</u>: per our contract for ambulance services, UCH is responsible for maintaining a contract with Weld County Communications Center for dispatch services and paying all associated costs. Our 2026 charges for dispatch services currently include UCH's share of costs. This is something that area chiefs are working through. Deducting UCH dispatch costs from our total results in a reduction of about \$23,000 for our 2026 dispatch charges.

STAFF RECOMMENDATION:

Staff requests input on the 2026 budget.

SUBJECT: Review & Consider Establishment of Sweep Account

PRESENTED BY: Sharon Bowles, Business Manager

AGENDA ITEM DESCRIPTION:

Following a review of District accounts and available options, staff determined it would be in the best interest of the District to establish a sweep account. This account will allow our cash-on-hand to be moved into an interest earning account, with funds "swept" into our checking account when needed to cover debits. Further details follow.

STAFF RECOMMENDATION:

Staff recommends holding District funds in a sweep account.



With Insured Cash Sweeps (ICS), you can benefit from the safety and simplicity that comes with access to multi-million-dollar FDIC insurance through a single bank relationship.

 - The crew really hit it out of the park while engaging with the community on current fire safety concerns / issues, and any questions and/or concerns related to the fire district. I'm pretty sure everyone in the park either had a fire district helmet, badge or pen! Great work!!!
 - We identified an opportunity to improve on the mobile food vending units that attend events in the Fire District.
 - Several of the vehicles failed the fire inspection conducted before the event started.

EMS

• UC Health compliance reporting for August was 95.7% for emergent calls (less than 8:30) and 90.2% for non-emergent calls (less than 12:00). UC Health has addressed the past response time issues with improving turnaround times from when they transport a patient to backfill posting locations faster. They are also working through some operational issues with changes in scheduling that they think they have figured out. We will continue to monitor this.

Training

• We are in the beginning stages of planning for a large-scale mutual aid training with LaSalle, Platte Valley, and Greeley FDs. It will be tentatively held in late October.

Community Outreach

- The annual open house was a success. Firefighter Malone did a great job organizing the event.
- Firefighter Malone managed the redesign of the District website. The new site is live and looks great.
- We attended a rain shortened Heritage Days which went well despite having bad weather during the event.





Election

- One "pro" statement was received in favor of the District sales tax ballot question; there was no "con" statement received. The TABOR notice was submitted to the County Clerk for distribution to voters.
- Ballots will be mailed beginning on October 10th.

Current Staffing

- 22 total staff members
 - o 18 full-time shift firefighters
 - 2 firefighters out on parental leave
 - 4 full-time administrative staff
 - Fire Marshal position shared with PV & LaSalle
 - 6 part-time firefighters

Around the Firehouse

- On 8/28, C-Shift responded to Hwy 85 & 31st St for a traffic accident. Crews arrived on scene and found a patient that was trapped in the vehicle. The patient was extricated and transported to the hospital.
- On 9/5, B-shift responded to a business on 23rd Ave at the request of Atmos energy to a gas leak that was underground. Surrounding businesses had to be evacuated for approximately 2 hours until the leak was stopped and the area was safe to operate.
- On 9/9, A-shift responded to the area of WCR 378 & 65th Ave on a water truck that had rolled over with the driver trapped inside. It took approximately 10 minutes to extricate the patient who was then transported to the hospital with serious injuries.
- On September 10th, A-Shift responded to the 3200 block of Lupton Ave on a possible structure fire. When crews arrived on scene, a neighbor was extinguishing a trash can that was on fire next to the garage. The was no damage to the actual structure and there were no injuries. The cause of the fire was improperly disposed ashes.
- On September 12th, B-Shift responded to the 3400 block of Reeves Ct. on a possible structure fire. Crews found a burned-up belt on the house's HVAC system that caused smoke in the residence.
- Around 2am on 9/17, A-Shift responded to the 1400 block of 11th Avenue in Greeley for a 2nd Alarm structure fire in a 4-story apartment building. Crews were cleared shortly after arriving.
- On 9/17, B-Shift responded mutual aid with PVFPD to Hwy 34 & WCR 49 for a traffic accident. A single vehicle had major damage, one person was extricated and transported to the hospital with serious injuries; the other party in the vehicle was a fatality.

• We had a handful of firefighters participate in the annual 9/11 stair climb at Red Rocks. There were over 2,000 firefighters and family members from throughout the state who attended.




- B-Shift attended the annual 9/11 First Responder appreciation at Dos Rios Elementary School. Members of the ATF and Evans PD also attended.


August 2025 Incidents

Count of Total Incidents


Count of Incidents


Incident Count by Day of Week


